- Completed proposed public engagement scope or work (Note: this is to be reviewed and approved by the Board)
- Submitted application for additional funding to the Province of Manitoba.
- Commenced collection of data sources in preparation of Component 2 (Background Research) of the project, and organized contents / layout for Background Report.
